3 | KELUARAN DALAM NEGERI KASAR (KDNK)

Perangkaan Akaun Negara (2010 = 100)

Pada tahun 2013, Jabatan Perangkaan (JPKE) telah menggunakan siri akaun negara tahun asas 2010 yang telah dikemaskini bagi menggantikan siri akaun negara tahun asas 2000. Siri Keluaran Dalam Negeri Kasar (KDNK) yang baru bagi Negara Brunei Darussalam (NBD) adalah konsisten dengan Sistem Akaun Negara 1993 dan 2008.

Mulai tahun tersebut juga, KDNK telah menggunakan tiga pendekatan baru iaitu pendekatan pengeluaran, pendekatan perbelanjaan dan pendekatan pendapatan. Dengan penggunaan siri KDNK yang telah disemak, menunjukkan gambaran yang lebih tepat tentang perkembangan ekonomi NBD masakini. Agregat makro-ekonomi yang lain seperti Pendapatan Negara Kasar (PNK) dan Tabung Negara Kasar (TNK) juga telah dihasilkan.

Keluaran Dalam Negeri Kasar (KDNK) adalah ukuran bagi jumlah nilai pengeluaran barang-barang dan perkhidmatan oleh unit pengeluar yang menetap dalam sesebuah ekonomi dalam tempoh perakaunan, biasanya satu tahun atau satu suku tahun.

KDNK boleh dikira menggunakan tiga pendekatan:

- (a) pendekatan pengeluaran,
- (b) pendekatan perbelanjaan, dan
- (c) pendekatan pendapatan.

Di dalam siri KDNK berdasarkan tahun 2000 bagi Negara Brunei Darussalam, dua pendekatan telah digunakan, iaitu pendekatan pengeluaran dan pendekatan perbelanjaan. Siri berdasarkan tahun 1974 yang lalu hanya menggunakan pendekatan pengeluaran sahaja.

KDNK Mengikut Pendekatan Pengeluaran

Di bawah pendekatan ini, KDNK ialah jumlah Nilai Tambah Kasar (GVA) bagi industri dalam ekonomi. GVA dikira bagi setiap aktiviti ekonomi dan kemudiannya dicampur untuk mendapatkan jumlah nilai tambah kasar atau KDNK bagi keseluruhan ekonomi, iaitu:

$$\text{KDNK} = \Sigma \text{GVA} + \text{Cukai tolak subsidi ke atas produk}$$

GVA diperolehi dengan menolak nilai barang-barang dan perkhidmatan yang digunakan dalam proses pengeluaran (dirujuk sebagai penggunaan perantaraan, IC) daripada nilai barang-barang dan perkhidmatan yang dihasilkan (disebut sebagai keluaran kasar, GO), iaitu:

$$\text{GVA} = \text{GO} - \text{IC}$$

KDNK mengikut pendekatan pengeluaran ditunjukkan mengikut jenis aktiviti ekonomi, berpandukan **Klasifikasi Standard Industri Negara Brunei Darussalam (BDSIC 2011)**, yang berdasarkan **Klasifikasi Standard Industri Antarabangsa (ISIC), Semakan 4**.

KDNK Mengikut Pendekatan Perbelanjaan

Pendekatan ini menilai penggunaan akhir bagi pengeluaran negara. Komponen perbelanjaan KDNK adalah berasaskan pembelian barang dan perkhidmatan untuk penggunaan akhir, dan kadangkala disebut sebagai agregat ‘permintaan akhir’ atau ‘perbelanjaan akhir’. Pembelian perantaraan barang dan perkhidmatan untuk pemerosesan selanjutnya adalah dikecualikan.

KDNK ialah jumlah perbelanjaan penggunaan persendirian (PCE), perbelanjaan penggunaan kerajaan (GCE), pembentukan modal kasar atau pelaburan (I) dan eksport (X) dikurangkan import (M) barang dan perkhidmatan, iaitu:

$$\text{KDNK} = \text{PCE} + \text{GCE} + \text{I} + \text{X} - \text{M}$$

Diskrepansi perangkaan (SD) dicampur kepada KDNK perbelanjaan untuk mencatatkan perbezaan dalam nilai KDNK daripada pendekatan pengeluaran dan perbelanjaan.

KDNK Mengikut Pendekatan Pendapatan

Pendekatan pendapatan adalah jumlah bayaran pekerja (CoE), penggunaan modal tetap (CFC), pendapatan lebihan operasi kasar dan pendapatan bercampur (OS) ditambah cukai bersih subsidi pada pengeluaran.

$$\text{GDP} = \text{CoE} + \text{CFC} + \text{OS} + \text{Cukai tolak subsidi ke atas produk}$$

KDNK Pada Harga Semasa dan Tetap

Bagi membolehkan berbagai jenis barang dan perkhidmatan dicampur dalam satu unit ukuran yang sama, KDNK dikira dalam nilai matawang. KDNK pada harga semasa merujuk kepada KDNK yang dikira pada harga semasa dalam tempoh perakaunan. KDNK pada harga semasa juga disebut sebagai KDNK nominal.

Memandangkan harga barang dan perkhidmatan berubah dari satu masa ke satu masa, perubahan dalam nilai KDNK mungkin disebabkan oleh perubahan dalam kuantiti barang dan perkhidmatan yang dihasilkan atau disebabkan perubahan harga. Oleh yang demikian, kesan dari perubahan harga perlu diasingkan untuk membolehkan perbandingan yang bermakna untuk melihat perubahan dalam paras atau kuantiti aktiviti ekonomi sepanjang masa tertentu. Ini memerlukan pertukaran KDNK harga semasa kepada harga tetap. KDNK pada harga tetap juga digelar KDNK sebenar.

Kadar Pertumbuhan KDNK

Perubahan dalam KDNK harga semasa, yang dikira oleh kadar pertumbuhan, menggambarkan kesan cantuman dari perubahan dalam paras harga dan juga kuantiti pengeluaran barang dan perkhidmatan dari satu tempoh ke satu tempoh yang lain.

Kadar pertumbuhan bagi KDNK pada harga tetap memberikan ukuran bagi pertumbuhan ‘sebenar’ dalam ekonomi kerana kesan dari perubahan harga telah dikecualikan.

Kadar pertumbuhan tahunan, r , dalam peratus bagi KDNK harga tetap (misalnya bagi 2017 dibandingkan dengan 2016) dikira seperti berikut:

$$r = ((\text{KDNK}_{2017} / \text{KDNK}_{2016}) - 1) \times 100$$

KDNK per kapita diperolehi dengan membahagi KDNK pada harga semasa dengan saiz penduduk. Ini digunakan untuk menunjukkan tahap perkembangan ekonomi sebagai perbandingan dengan negara-negara lain. KDNK per kapita juga dikira dalam harga tetap. Perubahan dalam KDNK per kapita pada harga tetap digunakan untuk menunjukkan kesejahteraan keseluruhan dalam ekonomi.

Explanatory Note

3 | GROSS DOMESTIC PRODUCT (GDP)

National Accounts Statistics (2010 = 100)

In 2013, the Department of Statistics (JPKE) has implemented the new series of national accounts with base year 2010 to replace the national accounts series with base year 2000. The new series for Brunei Darussalam (NBD) is consistent with the System of National Accounts 1993 and 2008.

Starting from that year, Gross Domestic Product (GDP) uses the three approaches namely the production approach, expenditure approach and income approach. Other macro-economic aggregates such as Gross National Income (GNI) and Gross National Savings (GNS) are also compiled in the new series.

Gross Domestic Product (GDP) is a measure of the total value of production of goods and services by all resident producing units in an economy during an accounting period, which is usually one year or one quarter.

GDP can be calculated by using three approaches:

- (a) the production approach,
- (b) the expenditure approach, and
- (c) the income approach.

In the 2000-based GDP series for Brunei Darussalam, two approaches are used, namely the production approach and the expenditure approach. The previous 1974-based series only used the production approach.

GDP by Production Approach

Under this approach, GDP is the sum of the value-added of the various industries in the economy. Gross Value Added (GVA) is calculated for every economic activity and then summed up to obtain the total gross value added or GDP for the whole economy, i.e.

$$\text{GDP} = \Sigma \text{GVA} + \text{Taxes less subsidies on products}$$

GVA is derived by deducting the value of goods and services used in the production processes (referred to as intermediate consumption, IC) from the value of goods and services produced (referred to as output, GO), i.e.

$$\text{GVA} = \text{GO} - \text{IC}$$

GDP by production approach is presented by kind of economic activities according to the **Brunei Darussalam Standard Industrial Classification (BDSIC 2011)**, which is based on the **International Standard Industrial Classification (ISIC), Revision 4**.

GDP by Expenditure Approach

This approach evaluates the final uses of the country's output. The GDP expenditure components are based on the purchases of goods and services for final use, and are sometimes referred to as 'final demand' or 'final expenditure' aggregates. Intermediate purchases of goods and services used for further processing are excluded.

GDP is the sum of private consumption expenditure (PCE), government consumption expenditure (GCE), capital formation or investment (I) and exports (X) less imports (M) of goods and services, i.e. :

$$\text{GDP} = \text{PCE} + \text{GCE} + \text{I} + \text{X} - \text{M}$$

A statistical discrepancy (SD) is added to the GDP by expenditure to record the difference in the GDP values obtained from the production and expenditure approaches.

GDP by Income Approach

The income approach is the sum of compensation of employees (CoE), consumption of fixed capital (CFC), gross operating surplus and gross mixed income (OS) plus taxes net of subsidies on production.

$$\text{GDP} = \text{CoE} + \text{CFC} + \text{OS} + \text{Taxes less subsidies on products}$$

GDP at Current and Constant Prices

In order to aggregate the wide variety of goods and services in a common unit of measurement, GDP is expressed in monetary terms. GDP at current prices refers to GDP measured at the prevailing prices in the current accounting period. GDP at current prices is also referred to as nominal GDP.

Since prices of goods and services change from one period to another, the change in GDP value may be due to changes in volume of the goods or services produced or due to price changes. Therefore, the effects of price changes have to be removed to enable a meaningful comparison to see the changes in the level or volume of economic activities over time. This requires the conversion of GDP current prices to constant prices. GDP at constant prices is also referred to as real GDP.

GDP Growth Rates

The changes in current price GDP, as measured by the growth rates, reflect the combined effect of the changes in the price level as well as the quantity or volume of production of goods and services from one period to another.

The growth rates of GDP at constant prices give a measure of the 'real' growth of the economy as the effects of price changes have been eliminated.

The annual growth rate, r , in per cent for GDP constant prices (for example, for 2017 compared to 2016) is calculated as follows:

$$r = ((GDP_{2017} / GDP_{2016}) - 1) \times 100$$

GDP per capita is obtained by dividing the GDP at current prices by the population size. This is used to indicate the level of economic development in comparison to other countries. GDP per capita is also computed at constant prices. The change in GDP per capita at constant prices is used to indicate the overall economic well-being.

4 | INDEKS HARGA PENGGUNA (IHP)

Indeks Harga Pengguna (IHP) dikumpulkan secara bulanan oleh Jabatan Perangkaan, Jabatan Perancangan Ekonomi dan Statistik, Kementerian Kewangan dan Ekonomi.

IHP mengukur perubahan harga pada sebakul tetap barang dan perkhidmatan yang dibeli oleh sebahagian besar isi rumah di Negara Brunei Darussalam. Ianya mengukur perubahan harga dari satu tempoh rujukan dikenali sebagai tempoh tahun asas. Indeks pada tempoh tahun asas ditetapkan dengan nilai indeks 100 dan perubahan harga pada tempoh masa berikutnya dikira dengan dihubungkan dengan nilai indeks ini. Tempoh tahun asas bagi IHP masa ini ialah tahun 2015 (Jan 2015=100).

IHP digunakan secara meluas bagi mengukur kadar inflasi sesebuah negara. Kadar inflasi adalah perubahan peratus dalam IHP dari satu tempoh ke tempoh yang lain. Kadar inflasi boleh dikira secara bulan-ke-bulan, tahun-ke-tahun dan tempoh-ke-tempoh. Kadar inflasi tahun-ke-tahun, misalnya, adalah peratus perubahan IHP pada bulan di bawah kajian dengan IHP pada bulan sebelumnya.

Bakul IHP mengandungi barang dan perkhidmatan yang biasa dibayar sebahagian besar isi rumah. Jumlah barang dan perkhidmatan dalam bakul masa ini adalah 411. Kewajaran ditetapkan bagi kesemua barang dan perkhidmatan IHP pada semua peringkat yang menunjukkan kepentingan sesuatu barang dan perkhidmatan. Barang dan perkhidmatan yang penting biasanya mempunyai kewajaran yang tinggi dan mempunyai kesan yang besar pada keseluruhan nilai IHP berbanding dengan yang kurang penting. Bakul IHP masa ini dan pengiraan kewajarannya adalah berdasarkan kepada Kajian Perbelanjaan Keluarga (KPK) tahun 2015. Klasifikasi barang dan perkhidmatan IHP dan kewajaran adalah seperti berikut:

IHP juga dapat dibahagikan kepada jenis barang mengikut tahan lama dan perkhidmatan seperti berikut:

- Barang tahan lama:** Barang yang digunakan berulangkali untuk jangka masa yang lama (contoh: perabot, peralatan isi rumah, kenderaan).
- Barang tahan lama (sementara):** Barang yang digunakan berulangkali tetapi mempunyai jangka hayat / masa yang pendek (contoh: pakaian, kasut, barang kaca, permainan, tekstil isi rumah).
- Barang tidak tahan lama:** Barang yang dapat digunakan sekali sahaja (contoh: makanan dan minuman).
- Perkhidmatan:** Perkhidmatan seperti pendidikan, kesihatan, perkhidmatan persendirian.

Explanatory Note

4 | CONSUMER PRICE INDEX (CPI)

The Consumer Price Index (CPI) is compiled on monthly basis by the Department of Statistics, Department of Economic Planning and Statistics, Ministry of Finance and Economy.

The CPI measures the changes in the prices of a fixed basket of goods and services purchased by the majority of household in Brunei Darussalam. It measures price changes from a reference period known as base year period. The index for the base year period is set to 100 and changes in prices in the following periods are measured in relation to this figure. The base year period of the current CPI is year 2015 (Jan 2015=100).

CPI is commonly used to measure the rate of inflation of a country. The inflation rate refers to the percentage change in the CPI from one period to another. Inflation rate can be measured on month-on-month, year-on-year and period-on-period basis. The month-on-month inflation rate, for instance, is the percentage change of the CPI in the month under review over the CPI in the previous month.

CPI basket comprises of goods and services commonly purchased by majority of households. The number of goods and services in the current basket is 411. Weights are assigned to CPI goods and services at all levels which indicate their relative importance. Important goods and services have more weights and thus have greater influence on the overall CPI than the less important. The current CPI basket and the computation of weights are based on the 2015 Household Expenditure Survey (HES). The classification of CPI goods and services and their weights are as follows:

The CPI can also be classified by the type of goods, according to their durability, and services, as follows:

Durable goods: *Goods that are used repeatedly or continuously over a long period of time (e.g. furniture, household equipment, vehicles).*

Semi-durable goods: *Goods that are used repeatedly but their expected lifetime use is less than for durables and their purchaser's value is significantly less (e.g. clothing, footwear, glassware, games, toys, household textiles).*

Non-durable goods: *Goods that are for single use only (e.g. food and drink).*

Services: *Services such as education, health, personal services.*

5 | IMBANGAN PEMBAYARAN

Jabatan Perancangan Ekonomi dan Statistik melalui Jabatan Perangkaan mengumpul perangkaan Imbangan Pembayaran (BOP) yang mana ianya meringkaskan transaksi ekonomi antara residen Negara Brunei Darussalam dan bukan residen. Perangkaan BOP menyediakan satu rangka kerja bersepada untuk penganalisaan ekonomi bagi hubungan ekonomi antarabangsa, ini termasuk prestasi ekonomi antarabangsa Negara Brunei Darussalam, polisi kadar pertukaran, pengurusan rizab dan pendedahan luaran.

BOP Negara Brunei Darussalam dikumpul mengikut piawaian antarabangsa yang ditetapkan dalam garispandu Imbangan Pembayaran, Edisi Keenam yang diterbitkan oleh Tabung Kewangan Antarabangsa (IMF). Transaksi ekonomi termasuk:

- transaksi eksport dan import barang dan perkhidmatan
- transaksi pendapatan utama kepada jumlah yang dibayar dan diterima dalam pulangan untuk menyediakan penggunaan sementara kepada entiti pekerja lain, sumber kewangan atau bukan pengeluar bukan kewangan aset
- transaksi pendapatan menengah yang menunjukkan pengagihan semula pendapatan
- perolehan dan pelupusan aset dan liabiliti kewangan

BOP terdiri daripada akaun barang dan perkhidmatan, akaun pendapatan utama, akaun pendapatan menengah, akaun modal dan akaun kewangan. Transaksi antarabangsa direkodkan dalam imbangan pembayaran adalah atas dasar prinsip catatan berganda digunakan dalam perakaunan perniagaan, di mana setiap transaksi menimbulkan dua penyertaan pengimbangan dengan nilai yang sama supaya dalam prinsip kredit dan debit yang terhasil penyertaan sentiasa seimbang.

Explanatory Note

5 | BALANCE OF PAYMENTS

The Department of Economic Planning and Statistics through the Department of Statistics compiles Balance of Payments (BOP) statistics which summarises the economic transactions between residents of Brunei Darussalam and non-residents. The BOP statistics provide an integrated framework for the analysis of an economy's international economic relationship, including Brunei Darussalam's international economic performance, exchange rate policy, reserve management and external vulnerability.

The Brunei Darussalam's BOP has been compiled in accordance with international standards set out in the Balance of Payments Manual, Sixth Edition published by the International Monetary Fund. The economic transactions include:

- transactions of exports and imports of goods and services
- transactions of primary income on the amount of payable and receivable in return for providing temporary use to another entity of labour, financial resources or non-produced nonfinancial assets
- transactions of secondary income which shows the redistribution of income
- acquisition and disposal of financial assets and liabilities

The BOP consists of goods and services account, the primary income account, the secondary income account, the capital account and the financial account. International transactions are recorded in the balance of payments on the basis of the double-entry principle used in business accounting, in which each transaction gives rise to two offsetting entries of equal value so that in principle the resulting credit and debit entries always balance.

PERANGKAAN BARANGAN PERDAGANGAN ANTARABANGSA *INTERNATIONAL MERCHANDISE TRADE STATISTICS*

Nota Keterangan**6****PERANGKAAN BARANGAN
PERDAGANGAN ANTARABANGSA**

Perangkaan Barang Perdagangan Antarabangsa terdiri daripada import dan eksport. Perangkaan import dan eksport berasaskan maklumat yang diperolehi daripada Jabatan Kastam dan Eksais Diraja, Kementerian Kewangan dan Ekonomi melalui deklarasi kastam dan Kementerian Tenaga.

Pengimpor dan pengekspor barang-barang adalah dikehendaki untuk membekalkan maklumat ke dalam deklarasi kastam bagi setiap konsainan barang niaga import atau eksport. Deklarasi ini disahkan oleh Jabatan Kastam dan Eksais Diraja dan dihadapkan ke Jabatan Perancangan Ekonomi dan Statistik untuk pemerosesan data dan penyebaran maklumat.

Negara Brunei Darussalam mempraktikkan *General System* dalam merekod Perangkaan Barang Perdagangan Antarabangsa yang hanya meliputi import, eksport domestik dan eksport semula yang diluluskan melalui kastam. Ini tidak termasuk:

- a) matawang kertas dan syiling dalam peredaran;
- b) barang-barang persendirian dan rumah yang tidak dikenakan duti kastam di Negara Brunei Darussalam dan digunakan oleh penumpang untuk kegunaan sendiri;
- c) stor dan bahan bakar dibekalkan kepada kapal laut dan kapal udara Brunei;
- d) artikel mengenai pinjaman atau sewa contoh peralatan-peralatan untuk kajian minyak dan ujian penggerudi dll.;
- e) barang-barang persinggahan;
- f) ikan dan lain-lain produk laut yang mendarat terus dari kapal menangkap ikan di kawasan perikanan Negara Brunei Darussalam;
- g) barang-barang yang diimport dan dieksport oleh atau bagi pihak perkhidmatan diplomatik; dan
- h) barang-barang yang diimport oleh angkatan bersenjata.

Klasifikasi Piawaian Perdagangan Antarabangsa Semakan 4 (SITC Rev.4), digunakan bagi penjenisan barang komoditi untuk kedua-dua import dan eksport.

Import merujuk kepada barang yang dibawa masuk ke dalam negara, sama ada secara terus atau disimpan dalam gudang sehingga cukainya dibayar, tanpa mengira sama ada barang tersebut untuk penggunaan, diproses, digunakan dalam perkilangan atau dieksport semula ke negara lain. Import dinilaikan mengikut *c.i.f (cost, insurance and freight - kos, insurans dan tambang)*.

Eksport merujuk kepada barang (keluaran atau buatan tempatan atau barang diimport untuk dieksport semula) yang dibawa keluar dari negara. Eksport dinilaikan mengikut *f.o.b (free on board)*. Eksport terdiri daripada eksport domestik dan eksport semula.

- **Eksport Domestik** terdiri daripada barang yang dikeluarkan di dalam Negara Brunei Darussalam.
- **Eksport Semula** merujuk kepada barang yang dibawa keluar dari negara dalam keadaan seperti mana ianya diimport tanpa mengalami sebarang perubahan bentuk. Proses membungkus semula, menyisih atau menggred tidak dikira sebagai satu proses perubahan bentuk.

Jumlah Perdagangan ialah jumlah nilai eksport (termasuk eksport domestik dan eksport semula) dan import.

Imbangan Perdagangan ialah perbezaan antara nilai eksport (termasuk eksport domestik dan eksport semula) dan import. Apabila eksport melebihi import, lebihan direkodkan dan defisit pula dicatatkan apabila import melebihi eksport.

Kategori Ekonomi Umum (Broad Economic Category-BEC) diklasifikasikan mengikut Klasifikasi Kategori Ekonomi Umum yang diperkenalkan oleh Pertubuhan Bangsa-Bangsa Bersatu dan sebagai cara untuk menukar data Standard International Trade Classification (SITC) kepada kategori penggunaan akhir. BEC menyediakan kategori selaras dengan 3 kelas barang utama dalam Sistem Akaun Negara (System of National Accounts - SNA):

- Barang Modal digunakan untuk menghasilkan barang atau perkhidmatan lain.
- Barang Perantaraan adalah separuh diproses, separa pembuatan dan pembekalan-perindustrian; dan diubah atau digunakan dalam pengeluaran barang dan perkhidmatan.
- Barang Penggunaan adalah produk akhir yang digunakan terutamanya oleh isi rumah untuk kegunaan akhir

Barangan perdagangan mengikut mod pengangkutan dikumpul mengikut cara pengangkutan yang digunakan untuk barangan masuk atau keluar daripada sesebuah ekonomi. Klasifikasi berikut adalah kategori utama mod pengangkutan:

1. Udara;
2. Laut;
3. Darat; dan
4. Lain-lain, termasuk penghantaran pos, mel atau kurier dan barang yang melintasi sempadan dan tidak mengaitkan urus niaga kepada sebarang kategori pengangkutan jenis tertentu.

Explanatory Note

6 | INTERNATIONAL MERCHANDISE TRADE STATISTICS

International Merchandise Trade Statistics comprises of imports and exports. The import and export statistics is based on the information captured by the Royal Customs and Excise Department, Ministry of Finance and Economy through the customs declarations and Ministry of Energy.

Importers and exporters of goods are required to furnish information in the customs declaration forms in respect of every consignment of merchandise imported or exported. These declarations are verified by the Department of Royal Customs and Excise which are then forwarded to Department of Economic Planning and Statistics for data processing and disseminations.

The General System of recording International Merchandise Trade Statistics practised by Brunei Darussalam only cover imports, domestic exports and re-exports that have been cleared through customs excluding:

- a) currency notes and coins in circulation;
- b) personal and household effects which do not incur any Brunei Darussalam customs duty and which are taken by passengers for their own use;
- c) stores and fuel supplied to Brunei ships and aircrafts;
- d) articles on loan or rent e.g. equipments for oil surveys and experimental drilling etc.;
- e) goods in transit;
- f) fish and other marine products landed from Brunei Darussalam fishing vessels direct from fishing grounds;
- g) goods imported and exported by or on behalf of diplomatic services; and
- h) goods imported by the armed forces.

The Standard International Trade Classification, Revision 4 (SITC Rev.4) is used to classify commodity items for both imports and exports.

Imports refer to goods brought into the country, either directly or into bonded warehouses, irrespective of whether such goods are for consumption, to be processed used in manufacturing or subsequent exports to other countries. Imports are valued on c.i.f (cost, insurance and freight) basis.

Exports refer to goods (locally produced or manufactured or imports for subsequent exports), which are taken out of the country. Exports are value on f.o.b (free on board) basis. Exports comprise of domestic export and re-export.

- **Domestic Exports** comprise of goods which are grown or produced in Brunei Darussalam.
- **Re-Exports** refer to goods taken out of the country in the same form as they were imported without any transformation. Re-packing, sorting or grading processes are not considered part of the transformation processes.

Total Trade is total of value of exports (including domestic exports and re-exports) and imports.

Balance of Trade is the difference between the value of exports (including domestic exports and re-exports) and imports. When exports exceed imports it is recorded as surplus while a deficit is registered when imports exceed exports.

Broad Economic Category (BEC) is classified in accordance to Broad Economic Category introduced by the United Nations and as a means for converting data compiled in terms of Standard International Trade Classification (SITC) into end-use categories. The BEC provides categories which can be aligned into 3 large classes of goods in the System of National Accounts (SNA):

- Capital Goods are used as means of producing other goods or services.
- Intermediate Goods are semi-processed, semi-manufactured and industrial-supplies; and transformed or used up in the production of goods and services.
- Consumption Goods are final product mainly used by households for final consumption

Merchandise trade in goods by mode of transport are compiled according to the means of transport used when goods enter or leave the economic territory of a country. The following classifications are the main categories of the mode of transport:

1. Air;
2. Sea;
3. Land; and
4. Others, include postal consignments, mail or courier shipments and goods crossing the border not to attribute a transaction to any specific mode of transport categories.

Perangkaan FDI dikeluarkan mengikut Aliran FDI dan Stok FDI mengikut komponen, aktiviti ekonomi dan negeri.

- Aliran FDI merujuk kepada jumlah pelaburan langsung asing rentas sempadan pada tempoh tertentu.
- Stok FDI mengukur tahap jumlah pelaburan langsung asing pada penghujung tempoh.
- Komponen
 - Ekuiti pelaburan terdiri daripada semua instrumen dan rekod yang dituntutan ke atas nilai baki sesuatu perbadanan atau kuasi-perbadanan iaitu selepas semua tuntutan pembiutang telah dipenuhi. Ianya termasuk pendapatan yang dilabur semula yang terdiri daripada saham pelabur langsung (mengikut penyertaan ekuiti) pendapatan yang tidak termasuk dividen.
 - Instrumen hutang merujuk kepada kedudukan hutang pelaburan langsung di antara syarikat-syarikat bersekutu. Ianya termasuk pinjaman dan kredit perdagangan.
- Aktiviti Ekonomi

- Negeri

FOREIGN DIRECT INVESTMENT

FDI are recorded according to Directional Principle. FDI implies that a resident equity in one economy exercises a significant degree of influence over the management of a business enterprise resident in another economy. Ownership of 10 percent or more of the ordinary shares or rating power (for incorporated enterprise) or the equivalent (for unincorporated enterprises) is taken as evidence of a significant degree of influence over management.

FDI statistics are presented by FDI Flows and FDI Stock according to components, economic activity and country.

- *FDI Flows refers to the value of cross-border transactions related to direct investment during a given period.*
- *FDI Stock measures the total level of direct investment at the end of period.*
- *Components*
 - *Equity consists of all instruments and records that acknowledge claims on the residual value of a corporation or quasi-corporation, after the claims of all creditors have been met. Reinvested earnings consist of the direct investor's share (in proportion to equity participation) of earnings not distributed as dividends.*
 - *Debts instrument refers to direct investment debt positions between affiliated enterprises. This includes loan and trade credits.*
- *Economic Activity*

This refers to the business activity that is reported by the companies through census or otherwise we can get this information from the Registrar of Companies and Business Names (ROCBN), Ministry of Finance and Economy. These activities are classified in accordance to International Standard Industrial Classification of all economic activities (ISIC Rev.4)
- *Country*

This is according to the investors' residential or registered addresses outside Brunei Darussalam. They are recorded according to their immediate source economy, rather than ultimate source economy.

Perbelanjaan Pembangunan (Rancangan Kemajuan Negara, RKN) dana yang diperuntukkan untuk membayai projek-projek RKN bagi perancangan lima (5) tahun.

iii. Perbelanjaan Biasa

a. Gaji Kakitangan

Perbelanjaan bagi pembayaran gaji bulan termasuk bonus, elaun sarahidup, elaun kurnia khas dan sebagainya.

b. Perbelanjaan Berulang-Ulang

Explanatory Note**8****GOVERNMENT FINANCE****Financial Year**

The fiscal year was adopted starting 2003 to record the Government finances to replace the previous format that is using calendar year. The fiscal year is from April to March.

Government Revenue

Collections received on behalf of the Government earned from the operation activities of the Ministry/Department. Government revenue is classified into two:

- i. Oil and Gas Sector
- ii. Proceeds from Government Operations

Government Expenditure

Three (3) types of government expenditure namely Charged Expenditure, Development Expenditure and Ordinary Expenditure

i. Charged Expenditure

Charged Expenditure such as civil list expenditure, pensions and benefits, salaries and allowances of members of the Public Service Commission (SPA)

ii. Development Expenditure

Development Expenditure (National Development Plan, RKN) funds allocated to finance RKN projects for five (5) years planning.

iii. Ordinary Expenditure

Ordinary expenditure are divided into employee salary, recurring expenditure and special expenditure.

a. Personnel Emoluments

Expenditure for monthly payment including bonuses, living allowance, special allowance and others.

b. Recurrent Expenditure

This allocation is usually applied and allocated to each Ministry / Department every year such as allocation for car maintenance, building maintenance, utility payments and others.

c. Special Expenditure

This allocation is specially applied to be held within one financial year only such as the provision to purchase vehicles, photocopy machines and others. However, the allocation for Special Expenditure has been eliminated starting of the financial year 2018/19.
