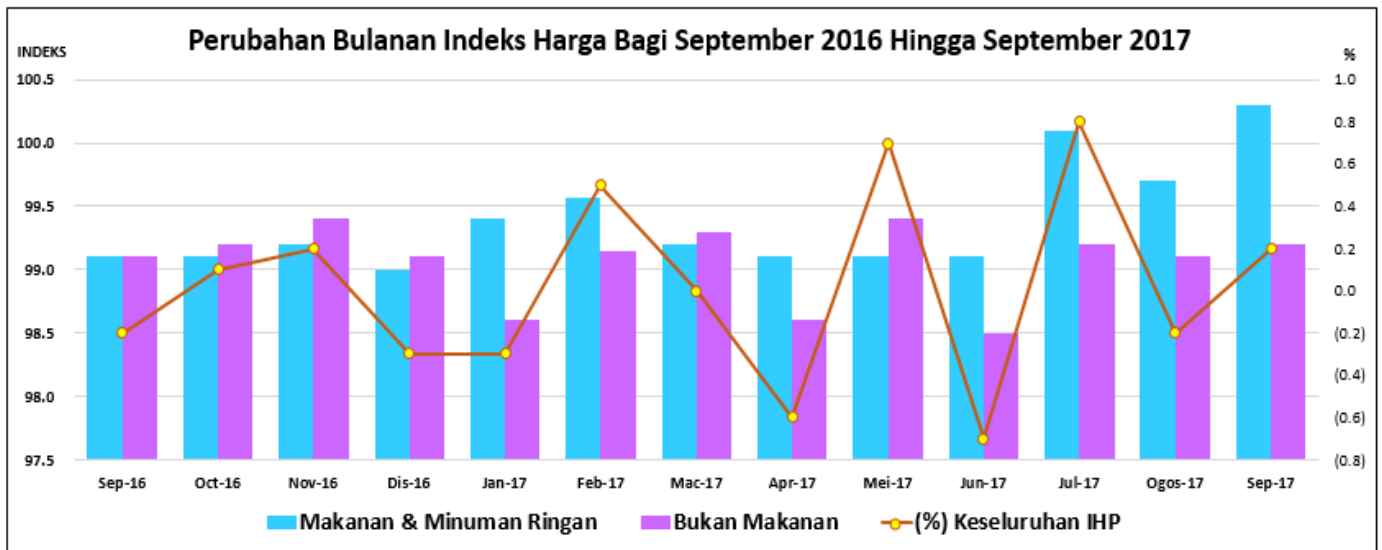

INDEKS HARGA PENGGUNA (IHP), SEPTEMBER 2017

1. Indeks Harga Pengguna (IHP) bagi bulan September 2017 meningkat sebanyak 0.3 peratus tahun-ke-tahun berbanding bulan September 2016. Indeks Makanan dan Minuman Ringan dan Indeks Bukan Makanan masing-masing mencatatkan peningkatan sebanyak 1.3 peratus dan 0.1 peratus tahun-ke-tahun.
2. Peningkatan IHP bagi bulan September 2017 sebahagian besarnya disebabkan oleh peningkatan Indeks Makanan dan Minuman Ringan (1.3 peratus); Pengangkutan (1.3 peratus); dan Rekreasi dan Kebudayaan (1.2 peratus). Ini adalah berikutan harga yang lebih tinggi pada Indeks Makanan dan Minuman Ringan bagi beras dan bijirin, daging, ikan dan makanan laut, minyak dan lemak, buah-buahan, sayur, produk makanan lain serta air mineral, minuman ringan, jus buah-buahan dan sayur. Manakala, kenaikan harga Indeks Pengangkutan adalah bagi kenderaan, basikal dan tiket penerbangan. Indeks Rekreasi dan Kebudayaan meningkat adalah disebabkan oleh peningkatan harga pada tanaman dan bunga, perkhidmatan rekreasi dan sukan serta pakej percutian dan umrah.
3. Bagi perubahan tempoh ke tempoh, IHP bagi Januari-September 2017 mencatatkan penurunan sebanyak 0.2 peratus berbanding dengan tempoh yang sama tahun sebelumnya. Indeks Makanan dan Minuman Ringan dan Indeks Bukan Makanan sama-sama mencatatkan penurunan sebanyak 0.2 peratus.
4. IHP mengukur perubahan harga barangan dan perkhidmatan yang dibayar oleh pengguna dalam satu tempoh masa ditetapkan dan dikumpulkan setiap bulan. Senarai barangan dan perkhidmatan dalam IHP adalah berdasarkan maklumat perbelanjaan purata sebuah keluarga yang diperolehi melalui Kajian Perbelanjaan Keluarga. CONSUMER PRICE INDEX (CPI), SEPTEMBER 2017

1. *Consumer Price Index (CPI) in September 2017 increased by 0.3 per cent year-on-year compared to September 2016. Both Food & Non-Alcoholic Beverages and Non-Food Index increased by 0.7 per cent and 0.2 per cent year-on-year, respectively.*
2. *The CPI increase in September 2017 was mainly attributed to increase in the indices of Food & Non-Alcoholic Beverages (1.3 per cent); Transport (1.3 per cent); and Recreation and Culture (1.2 per cent). These were mainly due to higher prices of the Food & Non-Alcoholic Index for rice and cereals, meat, fish and seafood, oil and fats, fruits, vegetables, other food products as well as mineral waters, soft drinks, fruit and vegetable juices. Meanwhile, higher Transport Index was due to increase in the prices of motor car, bicycles and passenger transport by air. Higher Recreation and Culture Index was due to higher prices of plants and flowers, recreational and sporting services as well as package holidays and pilgrimages.*
3. *On a period-on-period basis, CPI in January-September 2017 has decreased by 0.2 per cent compared to the same period last year. Food and Non-Alcoholic Beverages and Non-Food Index both decreased by 0.2 per cent.*
4. *CPI is a measure of price changes of goods and services paid by the consumer in a specified period and compiled on a monthly basis. The list of goods and services in the CPI is based on the average expenditure per household from the Household Expenditure Survey.
