





INDEKS HARGA PENGGUNA MENURUN 0.4 PERATUS BAGI BULAN OGOS 2025

Perbandingan bulan Ogos 2025 dan Ogos 2024

1. Indeks Harga Pengguna (IHP) pada bulan Ogos 2025 menunjukkan penurunan sebanyak 0.4 peratus berbanding bulan Ogos 2024, didorong oleh penurunan 0.4 peratus bagi kedua-dua indeks Makanan dan Minuman Ringan; dan indeks Bukan Makanan.
2. Penurunan bagi indeks Makanan dan Minuman Ringan adalah terutamanya disumbangkan oleh penurunan harga Sayur-sayuran (6.2 peratus), khususnya bawang merah; dan harga Daging (2.4 peratus), terutamanya daging ayam.
3. Bagi indeks Bukan Makanan, penurunan didorong oleh perbezaan kadar pertukaran matawang asing bagi perkhidmatan yuran langganan media atas talian dan perubahan kos insurans kenderaan bermotor.


Perbandingan bulan Ogos 2025 dan Julai 2025

4. Bagi perbandingan bulan-ke-bulan, IHP Ogos 2025 menurun sebanyak 0.2 peratus daripada bulan Julai 2025. Ini adalah didorong oleh penurunan sebanyak 0.3 peratus bagi indeks Bukan Makanan, manakala, indeks Makanan dan Minuman Ringan menunjukkan peningkatan sebanyak 0.1 peratus.
5. Penurunan bagi indeks Bukan Makanan adalah terutamanya didorong oleh Pelbagai Barang dan Perkhidmatan (1.1 peratus); dan Pakaian dan Kasut (2.7 peratus). Manakala, peningkatan bagi indeks Makanan dan Minuman Ringan adalah terutamanya disumbangkan oleh peningkatan harga Ikan dan Makanan Laut (0.6 peratus); dan Buah-buahan (0.7 peratus).
6. IHP mengukur perubahan harga bakul barang dan perkhidmatan tetap yang dibayar oleh pengguna dalam satu tempoh masa yang ditetapkan dan dikumpulkan setiap bulan. Senarai barang dan perkhidmatan dalam IHP adalah berdasarkan maklumat perbelanjaan purata sebuah keluarga yang diperolehi melalui Kajian Perbelanjaan Keluarga. 



CONSUMER PRICE INDEX DECREASED BY 0.4 PER CENT IN AUGUST 2025

Comparison of August 2025 with August 2024

1. *The Consumer Price Index (CPI) in August 2025 recorded a decrease of 0.4 per cent compared to August 2024, driven by declines of 0.4 per cent in both the Food and Non-Alcoholic Beverages index; and the Non-Food index.*
2. *The decrease in the Food and Non-Alcoholic Beverages index was mainly contributed by the decline in the prices of Vegetables (6.2 per cent), particularly shallots; and Meat (2.4 per cent), mainly chicken meat.*
3. *As for the Non-Food index, the decrease was driven by a change in exchange rate of online media subscription fee services and changes in motor vehicle insurance costs.*

Comparison of August 2025 with July 2025

4. *On a month-on-month basis, the CPI in August 2025 decreased by 0.2 per cent compared to July 2025. This was driven by a 0.3 per cent decrease in the Non-Food index, while the Food and Non-Alcoholic Beverages recorded an increase of 0.1 per cent.*
5. *The decrease in the Non-Food index was driven by the prices of Miscellaneous Goods and Services (1.1 per cent); and Clothing and Footwear (2.7 per cent). Meanwhile, the increase in the Food and Non-Alcoholic Beverages index was mainly contributed by an increase in the prices of Fish and Seafood (0.6 per cent); and Fruits (0.7 per cent).*
6. *The CPI is a measure of price changes of a fixed basket of goods and services purchased by consumers in a specified period and compiled on a monthly basis. The list of goods and services in the CPI is based on the average expenditure per household from the Household Expenditure Survey (HES).
