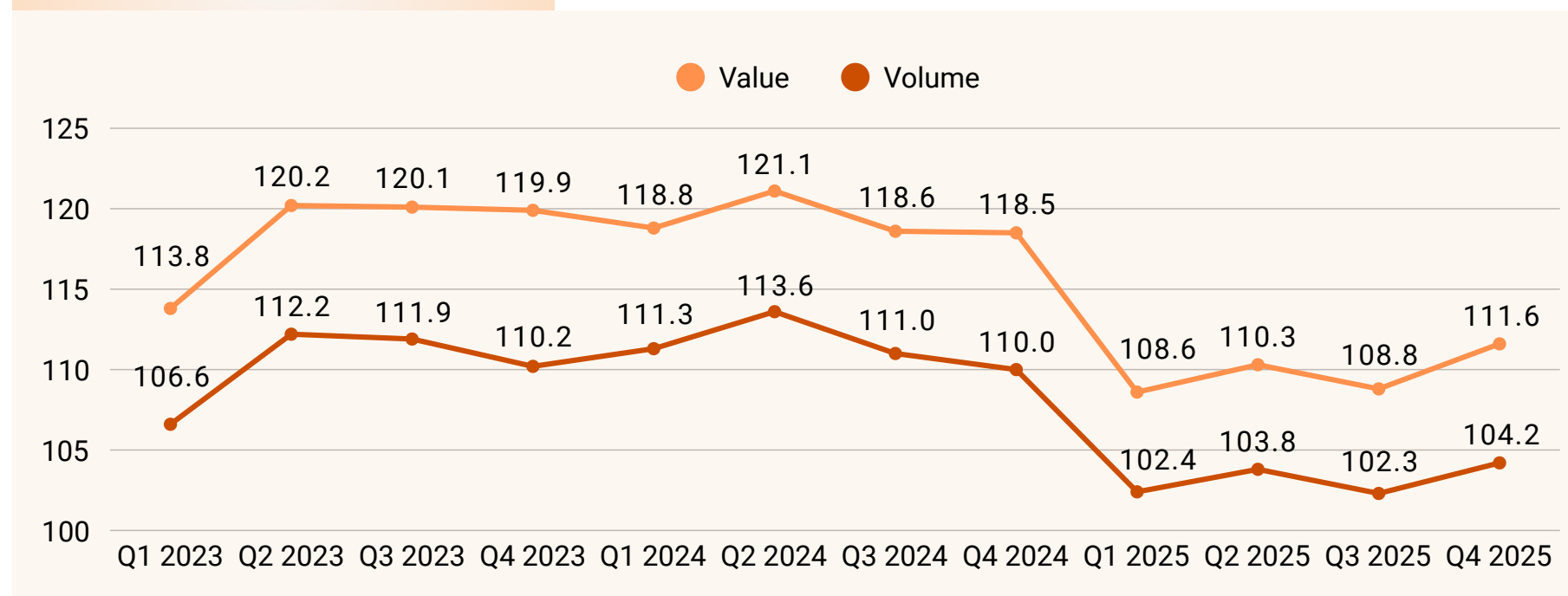
## SERVICES SALES INDEX FOURTH QUARTER (Q4) 2025

**VALUE OF SALES: BND2,335.1 MILLION**



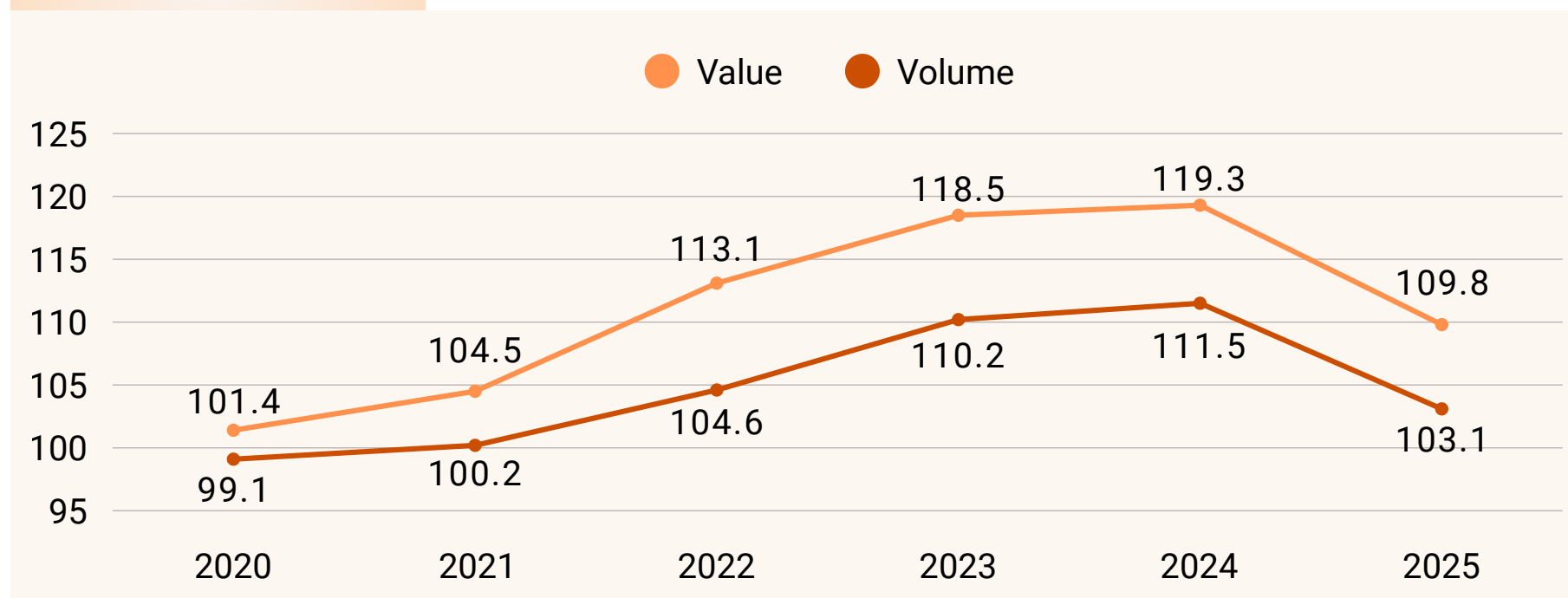

**Highlights Q4 2025**

In the fourth quarter (Q4) 2025, services sales recorded a negative growth of 5.9 per cent year-on-year, after decreasing by 8.3 per cent (revised from negative 8.2 per cent) in Q3 2025. On a quarter-on-quarter basis, services sales recorded an increase by 2.6 per cent following a decrease of 1.1 per cent in Q3 2025.

The total value of services sales in Q4 2025 was estimated at BND2,335.1 million, where 56.2 per cent of it was contributed by Wholesale and Retail Trade with sales worth BND1,312.9 million.

In terms of volume, services sales recorded a negative growth of 5.3 per cent year-on-year in Q4 2025, after decreasing by 7.8 per cent in Q3 2025. On a quarter-on-quarter basis, services sales recorded a positive growth of 1.9 per cent after decreasing by 1.4 per cent in Q3 2025 (**Table 1**).

**Highlights 2025**

In 2025, services sales recorded a decrease of 7.9 per cent after increasing by 0.6 per cent in 2024. Almost all of the services activities recorded negative growths, among the highest included Professional, Scientific and Technical Services 41.2 per cent; Wholesale and Retail Trade 4.1 per cent; Human Health and Social Work Activities 30.9 per cent; Information and Communication Services 5.8 per cent; and Real Estate Activities 8.5 per cent.

The total value of services sales in 2025 was estimated at BND9,191.6 million. More than half (56.7 per cent) was contributed by Wholesale and Retail Trade with sales worth BND5,211.7 million.

In terms of volume, services sales activity also recorded a negative growth of 7.5 per cent after increasing by 1.2 per cent in 2024. Almost all of the services activities recorded negative growths. The decline was mainly attributed to the decrease in the sales volume of Professional, Scientific and Technical Services 40.9 per cent; sales volume of Wholesale and Retail Trade 3.9 per cent; sales volume of Human Health and Social Work Activities 31.2 per cent; sales volume of Information and Communication Services 5.8 per cent; and sales volume of Real Estate Activities 8.5 per cent (**Table 2**).

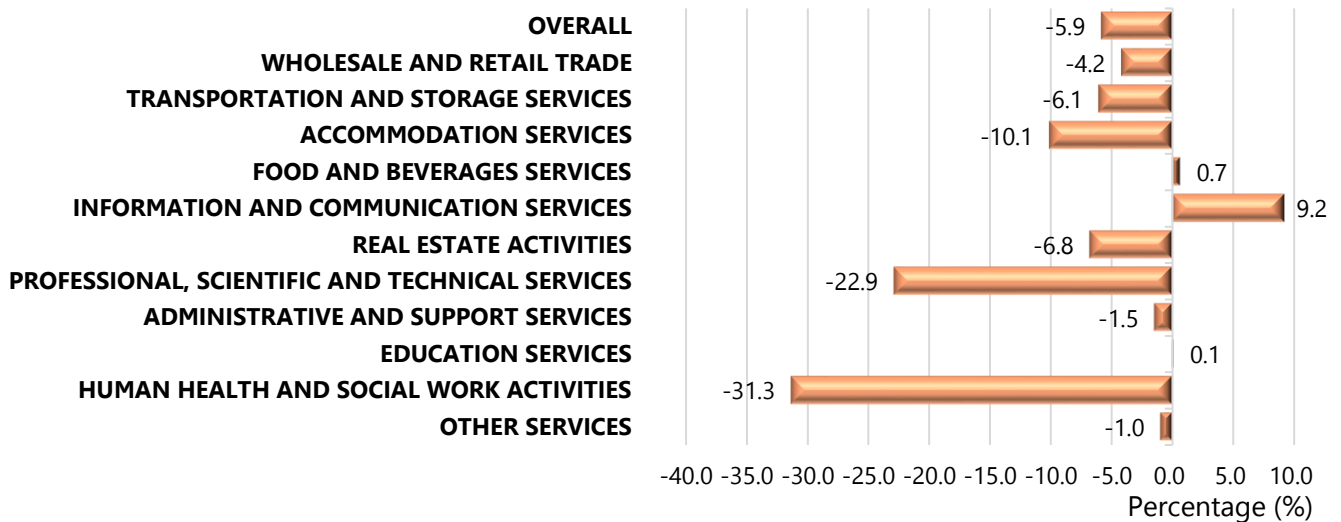
**Year-On-Year Change**

**Sales Value**

In terms of value, services sales recorded a decrease of 5.9 per cent in Q4 2025 compared to Q4 2024.

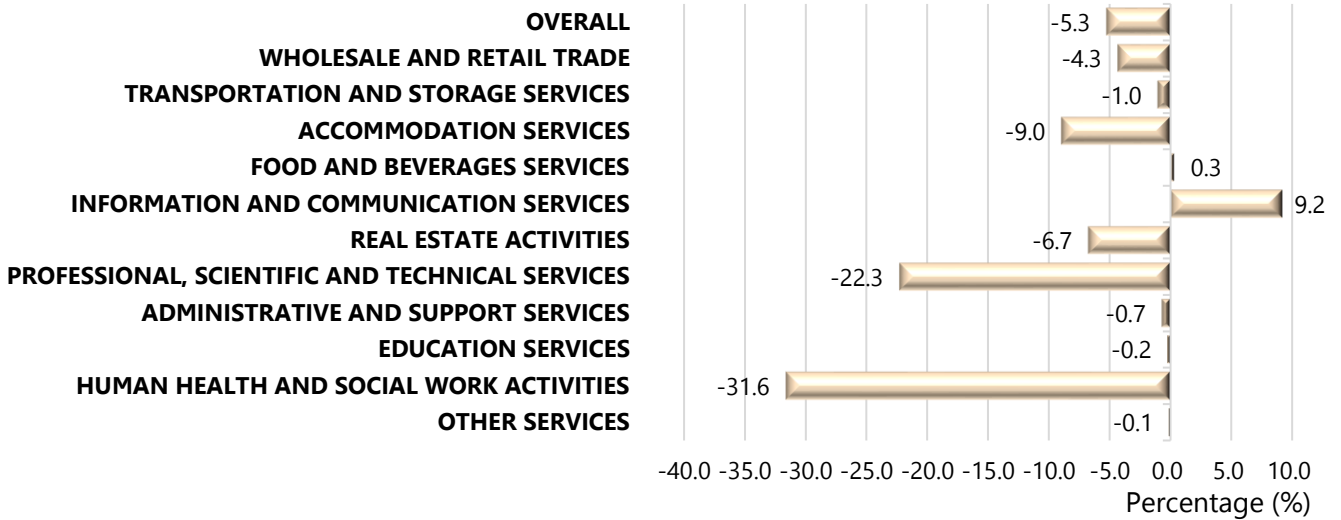
Figure 1: Services Sales Index Year-on-Year Value Change, Q4 2025

The lower demand in Q4 2025 was reflected in the decrease in sales revenue of Wholesale and Retail Trade 4.2 per cent; Professional, Scientific and Technical Services 22.9 per cent; Human Health and Social Work Activities 31.3 per cent; Transportation and Storage Services 6.1 per cent; and Real Estate Activities 6.8 per cent (Figure 1).

**Sales Volume**

In terms of volume, services sales volume recorded a decrease of 5.3 per cent in Q4 2025 compared to Q4 2024. This was mainly attributed to the decrease in the sales volume of Wholesale and Retail Trade 4.3 per cent; sales volume of Human Health and Social Work Activities 31.6 per cent; sales volume of Professional, Scientific and Technical Services 22.3 per cent; sales volume of Transportation and Storage Services 1.0 per cent; and Real Estate Activities 6.7 per cent (Figure 2).

Figure 2: Services Sales Index Year-on-Year Volume Change, Q4 2025



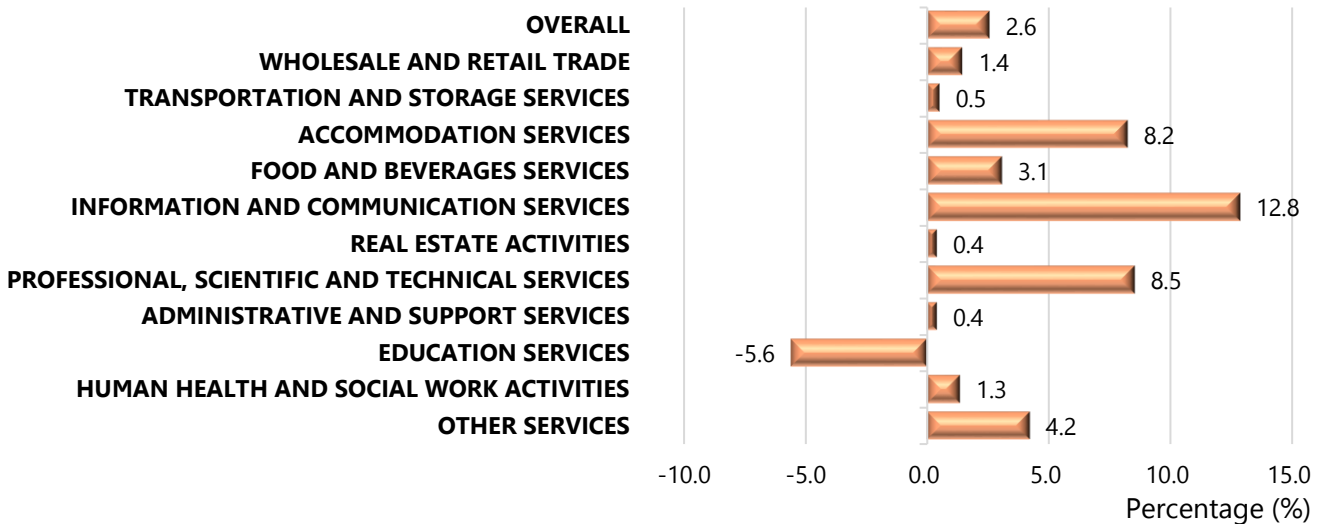
**Quarter-On-Quarter Change**

**Sales Value**

In terms of value, services sales recorded an increase of 2.6 per cent in Q4 2025 compared to Q3 2025.

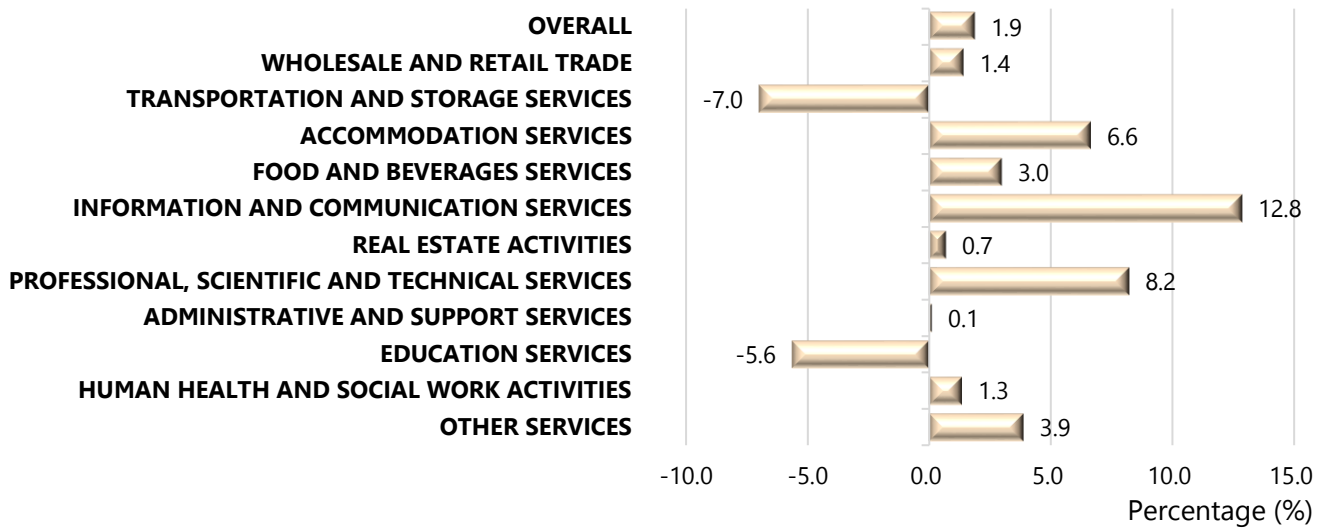
Figure 3: Services Sales Index Quarter-on-Quarter Value Change, Q4 2025

All services activities except Education Services recorded positive growths, among the highest included Information and Communication Services 12.8 per cent; Wholesale and Retail Trade 1.4 per cent; Professional, Scientific and Technical Services 8.5 per cent; Food and Beverages Services 3.1 per cent; and Transportation and Storage Services 0.5 per cent (Figure 3).

**Sales Volume**

In terms of volume, services sales volume recorded an increase of 1.9 per cent in Q4 2025 compared to Q3 2025. This was mainly attributed to the increase in the sales volume of Information and Communication Services 12.8 per cent; sales volume of Wholesale and Retail Trade 1.4 per cent; sales volume of Professional, Scientific and Technical Services 8.2 per cent; sales volume of Food and Beverages Services 3.0 per cent; and sales volume of Accommodation Services 6.6 per cent (Figure 4).

## TECHNICAL NOTES

### Introduction

Services refers to activities related to the services sector which provides intangible goods and services rather than physical products. It includes a wide range of activities where value is created through providing services to households, businesses or the government. Services sector is one of the important sectors that contributes to Brunei Darussalam's economy, accounting for nearly 75 per cent of the number of enterprises; employing around 67 per cent of the workforce; and generating about 39 per cent of the total operating revenue of the private sector in 2019.

The Services Sales Index (SSI) measures the movements of selected services activities. It serves as a leading economic indicator of the selected services sector performance as well as consumer spending behavior.

### Scope and Coverage

The Services activities are classified in accordance with the Brunei Darussalam Standard Industrial Classification (BDSIC) 2011 under Sections listed below, which is based on the United Nation's International Standard Industrial Classification (ISIC), Revision 4.

### Data Sources

SSI is compiled using data from the Quarterly Survey of Businesses (QSB) conducted by the Department of Economic Planning and Statistics (JPES) every quarter. A sample of 1,931 enterprises are covered in the QSB for services activities.

The weight for each activity reflects its relative importance in the overall services sector. The weights are computed based on the services sales of each activity obtained from the Annual Census of Enterprises (ACE) for reference year 2019.

### **Index Compilation**

The overall SSI is a weighted average of indices at the detailed activity level. The sales index at the activity level is derived by aggregating the sales value of enterprises belonging to the same activity and dividing it by the average quarterly sales for the same activity in the base year (2019). The overall SSI is then computed by summing all the weighted activities indices using the Laspeyres formula.

The indices and percentage changes will be published to one decimal place in the SSI reports. However, the computation of percentage changes is based on the unrounded index values.

The indices are reported both in value and volume terms. The indices in value terms measure the changes in sales value which may be due to changes in both price and quantity. The indices in volume terms measure the changes in volume of the services activities. These are done by removing the price effect by adjusting the nominal value using price deflators of the reference quarter.

### **Revision Policy**

Revisions will only be made to the published figures for the previous periods if there are any changes based on the latest available data.
