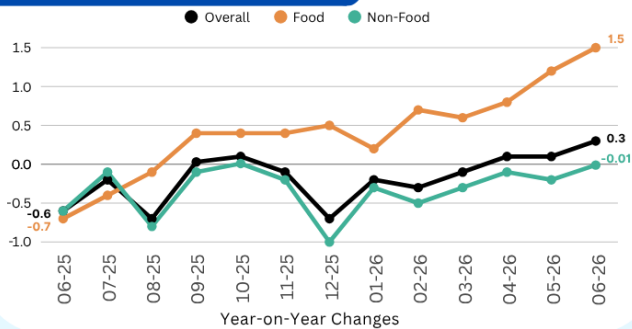

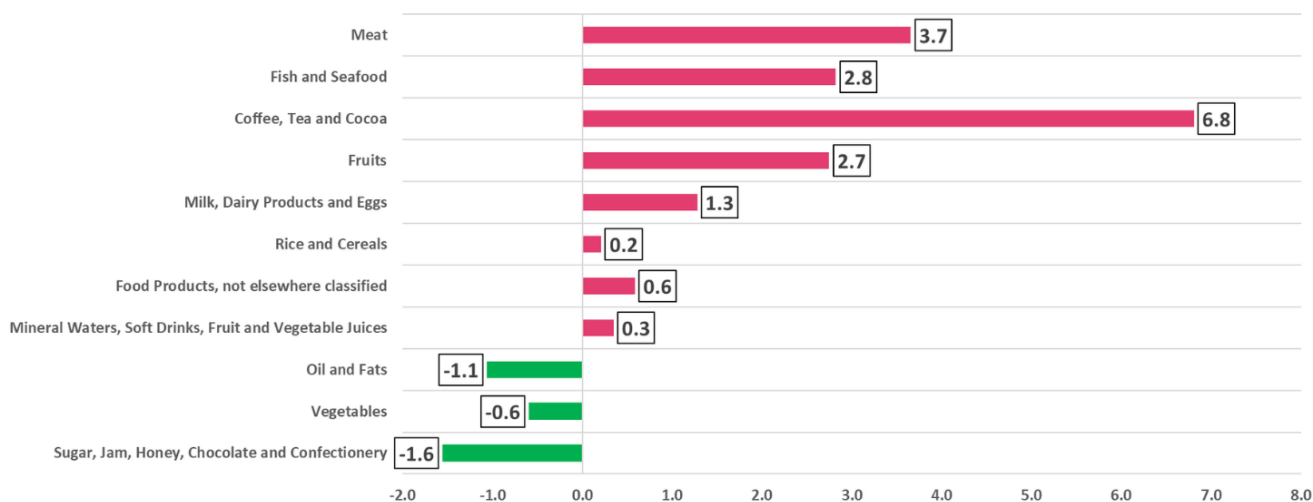

Year-on-Year Changes (%) by Non-Food Divisions



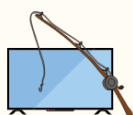

HIGHLIGHTS

In June 2026, the overall Consumer Price Index (CPI) has **increased** by 0.3 per cent year-on-year, from 106.0 in June 2025 to 106.3. This was contributed by an increase of 1.5 per cent in the Food and Non-Alcoholic Beverages index, while the Non-Food index registered a marginal decrease of 0.01 per cent. Meanwhile, the Goods index increased by 0.9 per cent, while the Services index decreased by 0.5 per cent.

Compared to May 2026, the CPI has **increased** by 0.2 per cent on a month-on-month basis, contributed by increases of 0.1 per cent and 0.2 per cent in the Food and Non-Alcoholic Beverages index and the Non-Food index respectively.

Periodically, the CPI for January to June 2026 recorded an overall decrease of 0.02 per cent compared to the same period in 2025 (**Table 1**).

YEAR-ON-YEAR CHANGES (JUNE 2026 COMPARED TO JUNE 2025)

Food and Non-Alcoholic Beverages have contributed 103.9 per cent to the overall year-on-year increase in June 2026, followed by Clothing and Footwear 42.9 per cent; and Restaurants and Hotels 20.0 per cent (**Figure 1** and **Table 2**).

Increases were recorded in:

- **Food and Non-Alcoholic Beverages** 1.5 per cent due to meat, such as chicken and beef; fish and seafood; and non-alcoholic beverages, particularly coffee, tea and cocoa (**Table 3**);
- **Clothing and Footwear** 3.5 per cent due to clothing materials; garments; and shoes and other footwear; and
- **Restaurants and Hotels** 0.5 per cent due to restaurants, cafes, fast-food outlets and others; and accommodation services.

Decreases were recorded in:

- **Communication** 3.5 per cent due to telephone and telefax services; and telephone and telefax equipment;
- **Miscellaneous Goods and Services** 0.6 per cent due to insurance; hairdressing salons and personal grooming establishments; and financial services; and
- **Transport** 0.2 per cent due to spare parts and accessories of vehicles; maintenance and repair of vehicles; and bicycles.

Figure 1: CPI Year-on-Year Changes, June 2026

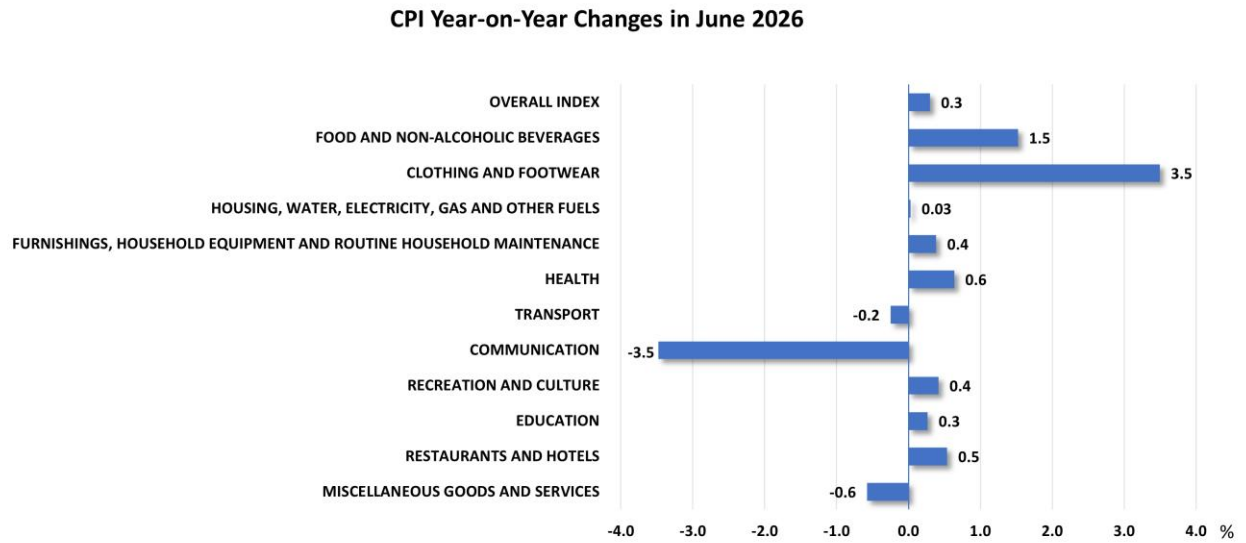

MONTH-ON-MONTH CHANGES (JUNE 2026 COMPARED TO MAY 2026)

The CPI in June 2026 has increased by 0.2 per cent from May 2026.

Recreation and Culture has contributed 42.7 per cent to the overall month-on-month increase of the CPI in June 2026, followed by Clothing and Footwear 24.3 per cent; and Transport 18.5 per cent (**Figure 2** and **Table 4**).

Increases were recorded in:

- **Recreation and Culture** 1.3 per cent due to equipment for sport, camping and open-air recreation; equipment for the reception, recording and reproduction of sound and pictures; and cultural services;
- **Clothing and Footwear** 1.3 per cent due to clothing materials; and
- **Transport** 0.2 per cent due to passenger transport by air; and motor cars.

Decreases were recorded in:

- **Housing, Water, Electricity, Gas and Other Fuels** 0.1 per cent due to rentals for housing; and
- **Communication** 0.1 per cent due to telephone and telefax equipment.

Meanwhile, the Education index remained unchanged.

Figure 2: CPI Month-on-Month Changes, June 2026

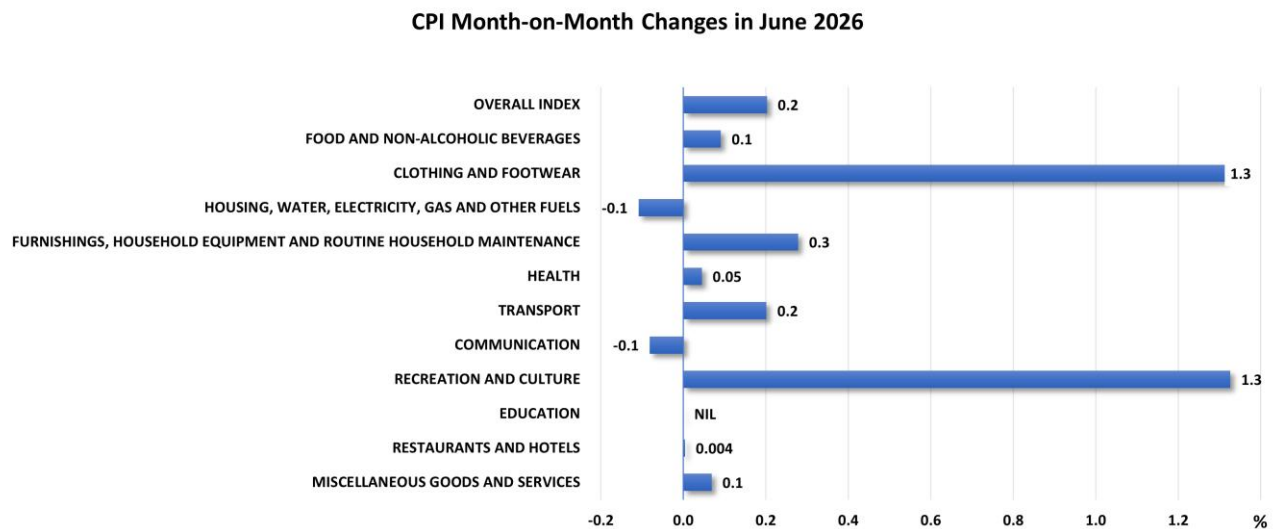

PERIOD-ON-PERIOD CHANGES (JANUARY - JUNE 2026 COMPARED TO JANUARY - JUNE 2025)

The average CPI from January to June 2026 has decreased by 0.02 per cent year-on-year compared to the same period in 2025.

Communication has contributed 824.8 per cent to the overall period-on-period decrease of the CPI from January to June 2026. This was followed by Recreation and Culture 449.2 per cent; and Miscellaneous Goods and Services 159.6 per cent (**Table 5**).

Decreases were recorded in:

- **Communication** 3.5 per cent due to telephone and telefax services; and telephone and telefax equipment;
- **Recreation and Culture** 1.5 per cent due to cultural services; package holidays/pilgrimages; and pets and related products; and
- **Miscellaneous Goods and Services** 0.4 per cent due to insurance; hairdressing salons and personal grooming establishments; and financial services.

Increases were recorded in:

- **Food and Non-Alcoholic Beverages** 0.8 per cent due to fish and seafood; meat; and fruits;
- **Restaurants and Hotels** 0.5 per cent due to restaurants, cafes, fast-food outlets and others; and accommodation services; and
- **Clothing and Footwear** 1.2 per cent due to clothing materials; garments; and shoes and other footwear.

GOODS ACCORDING TO DURABILITY AND SERVICES

For June 2026, the Goods index increased by 0.9 per cent, while the Services index recorded a decrease of 0.5 per cent, mainly due to internet service charges. The increase in Goods was contributed by durable, semi-durable and non-durable goods.

Meanwhile, compared to May 2026, the Goods index and the Services index increased by 0.3 per cent and 0.03 per cent respectively.

For the period from January to June 2026, the Goods index registered an increase of 0.4 per cent, while the Services index decreased by 0.6 per cent, compared to the same period in 2025 (**Table 6**).

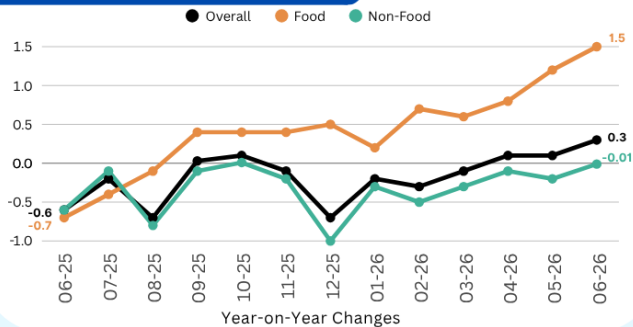

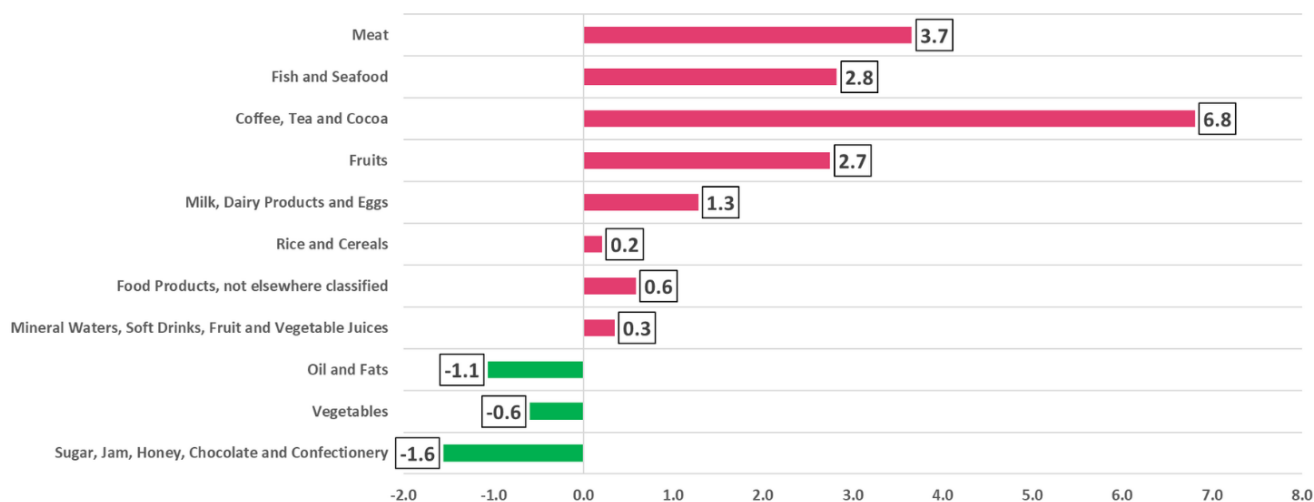

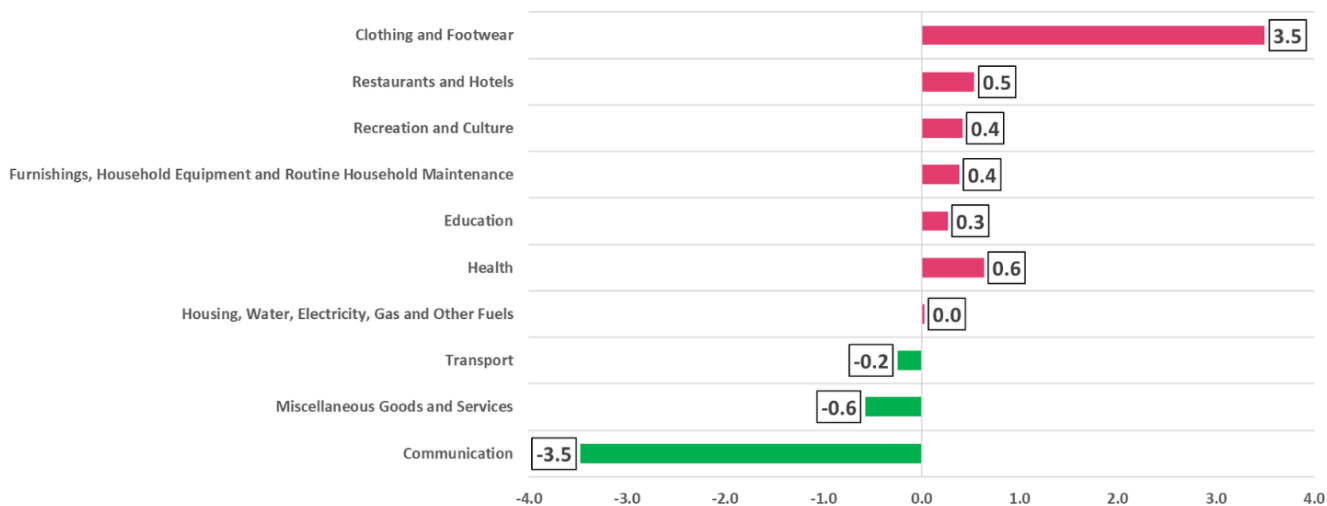

Year-on-Year Changes (%) by Non-Food Divisions



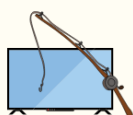

Figure 1: CPI Year-on-Year Changes, June 2026

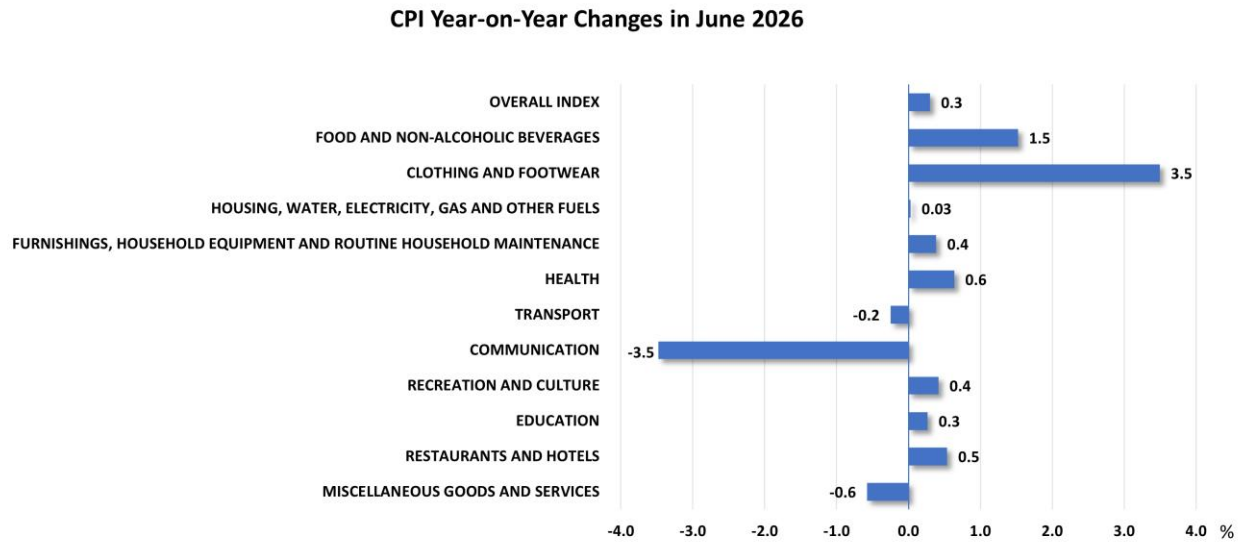

Figure 2: CPI Month-on-Month Changes, June 2026

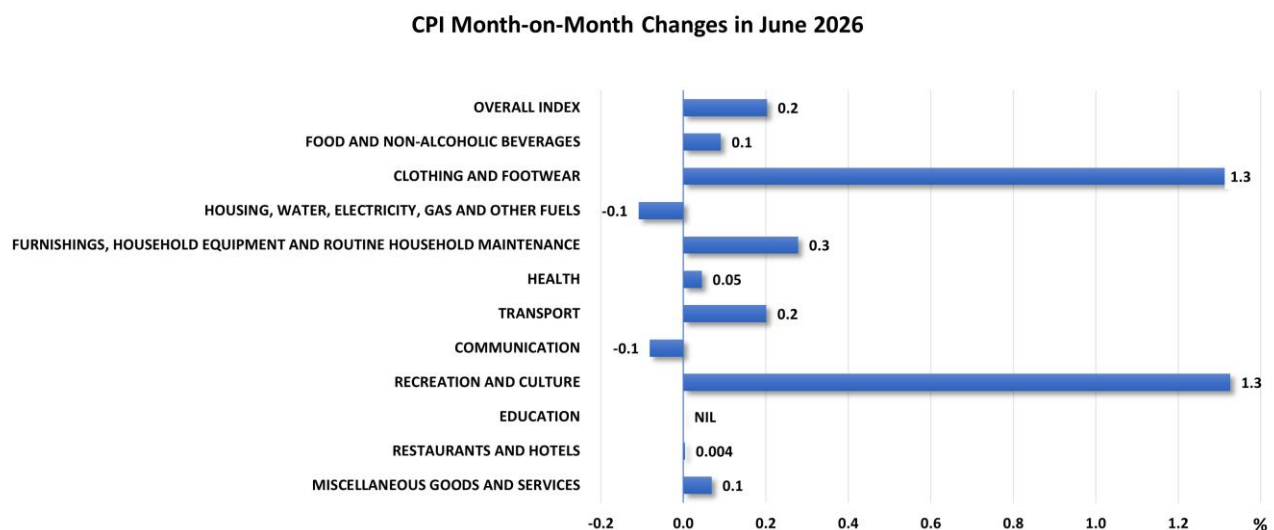

GOODS ACCORDING TO DURABILITY AND SERVICES

For the period from January to June 2026, the Goods index registered an increase of 0.4 per cent, while the Services index decreased by 0.6 per cent, compared to the same period in 2025 (**Table 6**).

Consumer Price Index Technical Notes

1. Concepts and Definitions

- 1.1 The Consumer Price Index (CPI) is a measure of the average change of prices paid by the household for a fixed 'basket' of goods and services over a period of time. The 'basket' of goods and services represents the average consumption pattern of the majority of households in Brunei Darussalam and it is derived from the results of a Household Expenditure Survey. The CPI is solely a measure of price changes and not a measure of changes in general cost of living.
- 1.2 As the CPI reflects the average changes in the prices of consumption goods and services, it is mainly used as a measurement of the rate of inflation. The CPI is also used as a deflator of other economic series such as the conversion of Gross Domestic Product (GDP) from current price values to constant price values.
- 1.3 The CPI basket covers a wide range of goods and services, classified according to the United Nation's "**Classification of Individual Consumption According to Purpose (COICOP)**". The goods and services are based on the final consumption expenditure of households. However, imputed rentals of owner-occupied housing and household expenditures abroad are excluded. Non-consumption expenditures such as donations, remittances, repayments of loans and purchase of real estate are also excluded.
- 1.4 The CPI can also be classified by the type of goods, according to their durability, and services, as follows:
- **Durable goods** : Goods that are used repeatedly or continuously over a long period of time (e.g. furniture, household equipment, vehicles)
 - **Semi-durable goods** : Goods that are used repeatedly but their expected lifetime use is less than for durables and their purchaser's value is significantly less (e.g. clothing, footwear, glassware, games, toys, household textiles)
 - **Non-durable goods** : Goods that are for single use only (e.g. food and drink)
 - **Services**: Services such as education, health, personal services.
- 1.5 The base year is used as the reference year for computing the weights of the CPI basket based on the results of the Household Expenditure Survey (HES). However, for the computation of price relatives, the average prices of the current month are compared with those of the previous month, instead of the average base year prices. The CPI calculation uses the chained index method, whereby the ratio of the average prices of the current month and the previous month is multiplied with the index value of the previous month.

2. Measurement of Changes in the CPI

2.1 The following changes are measured for the CPI:

- **Year-on-year changes:** the percentage change between the current month and the same month in the previous year;
- **Month-on-month changes:** the percentage change between the current month over the previous month; and
- **Period-on period changes:** the percentage change between the average index of the year-to-date compared to the same period the previous year. For example, the average index from January to June of the current year is compared to the average index from January to June the previous year.

2.2 The **contribution to change** column provides information on which goods or services have contributed most to the changes in the index. It is calculated by multiplying the weight of a particular item or group of items with the monthly change in the index for this item or group of items.

2.3 The annual inflation rate is taken as the percentage changes between the annual index of the reference year and that of the previous year.

3. Rounding Figures

3.1 The indices and percentage changes will be published to one decimal place in the CPI Report while significantly small non-zero digits will be published to one significant figure. However, the computation of percentage changes and contribution to changes are based on the unrounded index values.

4. Base Year of CPI

4.1 The CPI was rebased using data from the Household Expenditure Survey (HES) to reflect the latest consumption patterns of goods and services by households. The latest base year for the CPI was in 2015.
