## **Cheap Sale Price Regulations 2012**

Any businesses supply or offer to supply goods or services at cheap sale price has to notify to the Department of Economic Planning and Statistics (JPES) through the Department of Consumer Affairs

Section 3(1) of the Price Control (Cheap Sale Price) Regulations 2012



#### What are sales activities?

The selling of goods or services which involves the usage of:

- Comparative sale price (price before discount vs price after discount)
- Percentage of discount being displayed
- Words such as "Sale", "Discount", "Price Crash" and more...

## Two types of sale activities

Details	Regular Sales	Scheduled Sales	
1. Date of sales	By choice of businesses	Determined by JPES	BRUNE
2. Sales quota	4 times per year *excluding opening and closing sale	2 times per year (or as required/deem fit): - Brunei Salesbration (end of the year) - Jualan Aneka Brunei, Jualan Mega Brunei (Ramadhan - Syawwal)	let's shop & celebrate
3. Duration	21 days with 10 days extension (further discount)	50 – 70 days	HIALAN
		Oralan Olneka Salaman	JUALAN Mega Brunei  11 APRIL - 31 MEI 2022



#### **Notification Process**

1. Notification Form to JPES

Forms available at JPES counter or downloadable www.deps.gov.bn



2. Form Received

- Business details
- Read and agree to the terms and conditions
  - Email to sales@jpes.gov.bn



3. Issuance of Sales Notice

- Notify by phone
- Available for collection over the counter or by email

4. Display Notice

To be displayed at visible spots





# **Compliance Inspection**

- JPES will conduct random inspections
- Penalty will be imposed on non-compliance to the Sales Regulations


5 working days



### **Exemptions**

- Price reduction without indication of discount
- Discount with conditions
- Verbally agreed discounts

Discounts on perishable goods / 1 hour before closing









### **Penalty**

Non-compliance with the terms and conditions will face:

- Compound max \$1,000;
- Fine of \$5,000 and imprisonment for 2 years for the first offence by the court; or
- Fine of \$20,000 and imprisonment of 5 years for second or subsequent offence by the court.
